"Certificate of Insurance" means a certificate from an Insurance Company insuring the Exhibitor for public risk in respect to the exhibition for a sum not less than \$5,000,000.00 3. "Exhibition" means WMIW Inc Expo 2010. 4. "Exhibitor" means a business accepted by WMIW to occupy a stand area at the Exhibition for the purposes of promoting that business at the Exhibition. 5. "Payments" means the full payment. **Promoter's Covenants** 6. In consideration of the payments made by the Exhibitor to the Promoter, the Promoter grants a Licence to the Exhibitor to use the stand for the duration of the Exhibition. **Exhibitor's Covenants** 7. To make the payments in accordance with this Agreement. 8. To provide the Promoter with a current Certificate of Insurance with the completed booking form and full payment. 9. To indemnify the Promoter for all damages, loss and costs arising out of any actual or alleged default of the Exhibitor. 10. In the event that the Exhibitor shall make default in payment of any money due hereunder, the Exhibitor shall pay interest at the rate of ten per centum per annum on all monies overdue and unpaid during the period of the default. 11. Not to seek admission to the stand prior to 7am on 9th Oct 2010. 12. On completion of the exhibition, to leave the stand in a clean and tidy condition free from rubbish and debris. 13. Not to assign any of its rights to the stand or allow any other person or company to exhibit in the stand without express permission of the Promoter. 14. Not to seek damages, compensation or loss as against the Promoter for any change or restriction in the position or dimensions of the stand allotted to the Exhibitor or for the postponement, cancellation or delay in opening or premature closing of the exhibition, the failure of light and or power or other services or amenities to the exhibition where the action or inaction of the Promoter is not the cause of such damages, compensation or loss. 15. Not to claim refund unless notice of cancellation is given to the Promoter by the cancellation date. **General** 16. This Agreement shall be construed in accordance with and governed by the Laws of Victoria. **Cancellation policy** 17. Should you cancel your booking before 9th Oct 2010, you will find a replacement exhibitor or a charge of \$30.00 will be deducted from your refund for the Promoter to locate a replacement exhibitor. All cancellations after 31st August 2010 ('cancellation date') are non-refundable.
